COVID-19 Community Spread Confirmed in Iowa, Marion County Leadership take additional measures to limit the spread within the county. There are no current reported, positive cases in Marion County.

The Novel Coronavirus (COVID-19) is a rapidly, changing situation. Due to detection of substantial community spread in Iowa, new recommendations are being made and new mitigation measures should be implemented immediately for Marion County residents.

- Community spread occurs when individuals have been infected with the virus in an area and cannot specifically identify the source of the infection, or do not know how or where they became infected.
- The CDC recommends the following home isolation measures be taken if you are sick and if you will not have a test to see if you are still contagious. You can leave your sick room and home when:
  - No fever for at least 72 hours (3 days) **AND**
  - Other symptoms have improved AND
  - It has been 7 days since you started feeling sick.



#### **COVID-19 New Details:**

3/31/20 The Iowa Department of Public Health (IDPH) has been notified of 73 additional positive cases of Iowans with COVID-19, for a total of 497 positive cases. One death was reported in Muscatine County, a middle-aged (41-60) resident. There have been a total of 6,888 negative tests to date, which includes testing reported by the State Hygienic Lab and other labs. There are no reported positive cases in Marion County.

- Total cases: 163,539

- Jurisdictions reporting cases: 55 (50 states, District of Columbia, Puerto Rico, Guam, the Northern Mariana Islands, and the U.S. Virgin Islands)
- Since 03-13-2020 Marion County has had 43 tests that were negative.
- 3/29/20 President Trump said on Sunday that federal guidelines urging Americans to social distance to slow the spread of the coronavirus will remain in place for another month and could last until June; Trump said the guidelines will continue to ask Americans to socially distance until **April 30**.
- IDPH is encouraging us to remind people on the job; Take your temperature **BEFORE** coming to work and if you have a temp OR any respiratory symptoms that are not usual for you (ex; allergies, chronic cough) stay home!
- POISON ALERT: Serious Toxicity from Chloroquine and Hydroxychloroquine. As CQ and HCQ are being revitalized for the treatment of CoVID-19, it is important to remember the severe toxicity associated with its use. Ensure that patients are locking up these medications and not stockpiling, as even one tablet can be very toxic or fatal to a child.
